EXECUTIVE SUMMARY

The purpose of this item is to respond to council feedback about public participation during City Council meetings, share proposed changes to City Council meeting protocols, and seek input from council on several items. This memo will outline some of the items that have surfaced, include some updates, and detail additional options for council to consider and potentially adopt in the future.

PUBLIC FEEDBACK

Staff have heard feedback from community members and council indicating support for additional Chat/Walk with Council opportunities. Staff heard this feedback during Chats/Walks with Council and have also observed healthy numbers of community members participating as well as engaging with council members in more back-and-forth dialogue.

There has also been some input from the community on hybrid council meetings since Summer 2022, when this program was implemented, including a request from some council members for clarity on opportunities for virtual meeting participation.

BACKGROUND

The Council Subcommittee on Engagement and a Welcoming Council Environment is considering several changes to public participation protocols during council meetings that

are intended to increase meaningful engagement and the effectiveness of community members' testimony.

The issues to be discussed fall into one of four categories:

- 1. Updates related to Council Correspondence;
- 2. Expectations for Hybrid Council Attendance;
- 3. Improvements related to Chats and Walks with Council; and
- 4. Improvements related to Open Comment and Public Hearings.

ANALYSIS

Under each of the four categories listed above, staff and council subcommittee members have included several updates and identified several potential changes the subcommittee would like to bring to the full council for consideration.

1. Updates related to Council Correspondence

As City Council may recall, the city initiated a new approach to council correspondence in early 2022. The change was designed to move this communication away from Outlook, which was proving to be both cumbersome and ineffective, to a transitional system that involves community members completing a form. The form, in English and Spanish, allows the constituent to indicate the topic they are writing about as well as whether they wish the communication to go to council, staff, or both.

The system has streamlined the back-end management of these emails considerably and allowed the city to perform data analysis that was not possible previously. Attachment A of this memo is a year-end report on the new system.

One of the reasons behind the change was to make it easier for staff and council to identify emails that might need a response. The new system has helped with this; however, staff recognizes that more needs to be done to ensure that community members are receiving responses, when appropriate and especially in cases where they are seeking readily available information. The subcommittee and staff are in alignment on a few incremental changes to the form system that could help address this.

Before these are detailed, it might help council members to know that additional tracking capabilities are envisioned as a part of the upcoming Constituent Relationship Management project. This project was delayed in 2022 due to prioritization of other key projects. However, the Innovation and Technology Department has shared that this work will resume, starting in 2023, in phases, as shown here:

You will see that Phase 1 includes addressing known issues related to council correspondence and council Hotline. While the exact timing will be determined through scoping work, the goal is to complete Phase 1 by the end of 2023.

In the meantime, as mentioned previously, staff and the subcommittee are seeking the full council's feedback on two changes to the form system. These are as follows:

And no council member may participate remotely in more than three in- person council meetings per calendar year.

3. Improvements related to Chats and Walks with Council

Chats and Walks with Council have existed in the city since 2019. As we prepare for a discussion about their future, it may be helpful to take a quick look at their history.

The original pilot effort stemmed from a desire by council to engage with community members beyond what is possible in the time-limited open comment and public hearing context. The city held several staff-supported chats that year with a range of participation from 50 at one to 2 at another.

After the first year of the programming, staff returned to council to seek feedback. In general, the feedback was positive and led to a decision to continue to effort. There was, however, a request at that time to design the sessions in ways that accomplished the following:

- 1. For chats, emphasize participation and a welcoming environment for individuals who historically do not participate in council meetings; and
- 2. For walks, emphasize inclusivity AND choose routes and itineraries that showcased city initiatives or a complicated policy issue that could be a focal point of the walk.

This direction has guided staff's work in this space since that time.

In 2022, the city hosted six Chats and Walks with Council and engaged approximately 195 community members. Four Chats with Council were held in partnership with Community Connectors-in-Residence and our Nepali community, Naropa University, City of Boulder Climate Initiatives, Boulder Housing Partners, and Boulder Public Library and two Walks with Council were held in partnership with Fairview High School and University of Colorado.

Major conversation themes from 2022 Chats and Walks with Council included (in order of frequency) affordable housing, homelessness, city resources and how to access them, supportive services (e.g., mental health, addiction recovery, people with disabilities), public safety, and climate action and environment.

Positive feedback from 2022 Chats and Walks with Council included acknowledgement of low barrier participation – organic conversations, no sign-up or registration required, most events planned where people already are, interpretation support (for three Chats); engagement with diverse community members; and accompanying with existing events allowed for engagement with representatives with local partner organizations. Please see Attachment B for a recap of 2022 Chats and Walks with Council and Attachment C for a summary of proposed opportunities for council members to engage in two-way dialogue with community members.

Times/days of the week may vary, and Saturday mornings seem to work well for community members. During council election years, only council members who are NOT running for reelection may participate in Chats or Walks between mid- August to mid- November.
Consider adding two additional Chats each year that provide an avenue for council to engage on specific and timely topics.	Council input requested	Yes	To stand-up these Chats, at least three council members would need to initiate and participate, giving staff at least three weeks lead-time for planning and coordination. During council election years, only council members who are NOT running for reelection may

4. Improvements related to Open Comment and Public Hearings

With the goal of ensuring a welcoming council environment, the following potential changes are proposed to Open Comment, Public Hearings, and Council Chambers.

Eliminate community member slideshows during Open Comment and Public Hearing, to reflect a more equitable hybrid approach and to align with CAO recommendation.	Input from council needed	Yes	From time to time, community members request to display presentations they have created when testifying before council. This has been raised as an area of concern by the City Attorney's Office. There is no process for staff review of these presentations and even if there were, it would be challenging for the city to make content-based decisions about which to allow and which to prohibit. In addition, there are equity concerns related to some community members having access to the tools and knowledge to create these and others not. The recommendation is to prohibit them entirely to

			address both these concerns and create a level playing field for individuals sharing their input with council. Community members who wish to share slides or photos with council could still do so through the Contact Council form process. This would require a rule change.
Revise Council Rules of Decorum to address community member signs in Chambers, ensuring that sign size not block view or take neighbor's space and to clarify that seats are for people.	Input from council needed	Yes	As council has returned to Chambers, there has been a noticeable trend of community members placing signs in the seats in the front rows. The recommendation is for a rule change that would make clear that seats are for people not signs and that staff will remove signs that are placed in chairs. All other provisions about not blocking people's views or taking up your neighbor's space would still apply.

NEXT STEPS

Reflecting on the will of council, staff may implement proposed changes outlined above.


City Council Contact Form 2022 Data Report


