Item 5B - 2nd Rdg Ballot Items

Second reading and consideration of ordinances related to the 2023 ballot measures.

PURPOSE

The purpose of this memorandum is to describe some amendments that are the result of communications with petition committees. It also provides suggestions for motions to amend measures. It is anticipated that the council will take final action on the 2023 ballot measures at its August 17 meeting.

DESCRIPTION

Safe Zones 4 Kids – Ordinance 8586

Staff corresponded with the Safe Zones 4 Kids petition committee on July 27, 2023, wherein the petition committee requested to change its ballot measure language to remove the words "or sidewalk." This change was accomplished by removing the words "or sidewalk" from the title, motion, and ballot question language. The affected ordinance language is highlighted in yellow in attached amended Ordinance 8586.

Ordinance 8586 title and motion language now reads:

Second reading and consideration of a motion to amend and pass Ordinance 8586 submitting to the qualified electors of the city of Boulder at the General Municipal Coordinated Election to be held on Tuesday, November 7, 2023, the question of whether or not to amend Section 8-3-21, "Prohibited Items," B.R.C. 1981, to prioritize removal of prohibited items, such as tents, temporary structures, or

propane tanks, within five hundred feet of a school or fifty feet of any multi-use path; specifying the form of the ballot and other election procedures; and setting forth related details

Motion to amend and pass Ordinance 8586 submitting to the qualified electors of the city of Boulder at the General Municipal Coordinated Election to be held on Tuesday, November 7, 2023, the question of whether or not to amend Section 8-3-21, "Prohibited Items," B.R.C. 1981, to prioritize removal of prohibited items, such as tents, temporary structures, or propane tanks, within five hundred feet of a school or fifty feet of any multi-use path; specifying the form of the ballot and other election procedures; and setting forth related details

Charter Amendments – Ordinance 8587

There are no changes to Ordinance 8587. Council is requested to take no action on this item. Second reading and consideration of a motion to adopt Ordinance 8587 will be brought back to council on August 17, 2023.

Sales and Use Tax Extension

1. Ordinance 8588, city's Sales and Use Tax extension ballot measure:

There are no changes to the city's tax extension Ordinance 8588. Council is requested to take no action on this item. Second reading and consideration of a motion to adopt Ordinance 8588 will be brought back to council on August 17, 2023.

2. Ordinance 8589 (Arts for Boulder) Sales and Use Tax extension ballot measure:

Staff met with the Arts for Boulder petition committee on July 27, 2023, regarding ballot language for its Sales and Use Tax extension (Ordinance 8589). The petition committee proposed simplified ballot question language for its measure by removing reference to the Colorado Constitution in the middle of the ballot question itself and leaving that language at the end of the question. The committee also simplified its description of the services that will benefit from the tax revenue. Staff made the suggested changes. The affected ordinance language is highlighted in yellow in attached amended Ordinance 8589.

Ordinance 8589 title and motion language now read:

Second reading and consideration of a motion to amend and pass Ordinance 8589 submitting to the registered electors of the city of Boulder at the General Municipal Coordinated Election to be held on Tuesday, November 7, 2023, the question of, without raising additional taxes, extending the existing 0.15 cents city Sales and Use Tax approved by the voters by Ordinance 7300 beyond the current expiration date of December 31, 2024, until December 31, 2044, and earmark the revenue from this tax extension to fund arts, culture, and heritage; as a voter approved

revenue change; specifying the form of the ballot and other election procedures; and setting forth related details

Motion to amend and pass Ordinance 8589 submitting to the registered electors of the city of Boulder at the General Municipal Coordinated Election to be held on Tuesday, November 7, 2023, the question of, without raising additional taxes, extending the existing 0.15 cents city Sales and Use Tax approved by the voters by Ordinance 7300 beyond the current expiration date of December 31, 2024, until December 31, 2044, and earmark the revenue from this tax extension to fund arts, culture, and heritage; as a voter approved revenue change; specifying the form of the ballot and other election related procedures and setting fort related details

3. Ordinance 8591 (compromise between the city and petitioners) Sales and Use Tax extension ballot measure:

Staff met with the Arts for Boulder petition committee on July 27, 2023, regarding its Sales and Use Tax ballot language. During this meeting, the petition committee proposed simplified ballot measure language for the city's compromise measure (Ordinance 8591). The committee requested expanding on the fund split language: 50 percent of the revenue would be used for city services and general fund purposes and 50 percent of the revenue would be used for arts, cultural, and heritage program including direct and grant funding for arts and culture nonprofits, professional artists, arts education, venues and workspaces, public art, and multi-cultural programs. Staff agreed with the language proposed and made the suggested changes. The affected ordinance language is highlighted in yellow in attached amended Ordinance 8591.

Ordinance 8591 title and motion language now read:

AN ORDINANCE SUBMITTING TO THE REGISTERED ELECTORS OF THE CITY OF BOULDER AT THE GENERAL MUNICIPAL COORDINATED ELECTION TO BE HELD ON TUESDAY, NOVEMBER 7, 2023, THE QUESTION NOT TO SECTION WHETHER OR **AMEND** 8-3-21, "PROHIBITED ITEMS," B.R.C. 1981, TO PRIORITIZE REMOVAL OF PROHIBITED ITEMS, SUCH AS TENTS, TEMPORARY STRUCTURES, OR PROPANE TANKS, WITHIN FIVE HUNDRED FEET OF A SCHOOL OR FIFTY FEET OF ANY MULTI-USE PATH; SPECIFYING THE FORM OF THE BALLOT AND OTHER ELECTION PROCEDURES; AND SETTING FORTH RELATED DETAILS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BOULDER,

COLORADO:

Section 1. On June 9, 2023, a petition committee presented a petition with sufficient signatures of registered electors to initiate a vote on proposed amendments to the Boulder Revised Code pursuant to Sec. 39 of the Boulder Home Rule Charter. Under Charter Sec. 40, the City Council is required to either enact the proposed ordinance or set the ballot title for the proposed amendment.

Section 2. A general municipal coordinated election will be held on Tuesday, November 7, 2023.

Section 3. At the election, an initiative will be set forth for voters to consider a change to Section 8-3-21, B.R.C. 1981, to prioritize removal of prohibited items, such as tents, temporary structures, or propane tanks, within five hundred feet of a school or fifty feet of any multi-use

Section 4. At the election, a question shall be submitted to the electors of the city of Boulder eligible by law to vote, that will allow voters to determine whether Section 8-3-21, B.R.C. 1981, should be amended, unless council decides to pass the measure instead of referring it to the voters. The material to be added is shown in Section 5 below as underlined.

Section 5. If a majority of all the votes cast at the election on the measure submitted are for the measure, the measure shall be deemed to have passed and the Boulder Revised Code shall be amended to read as follows:

8-3-21. - Prohibited Items.

- (a) No person shall erect or use any tent, net, or other temporary structure for the purpose of shelter or storage of property in a park or recreation area, on any open space land, or on any other public property, unless done pursuant to a written permit or contract from the city manager. The prohibitions of this section do not apply to temporary shade structures in any park or recreation area within the corporate limits of the city. A temporary shade structure is a structure such as an umbrella or awning that provides overhead covering or weather protection, but not designed for overnight use or privacy and cannot be fully enclosed. No temporary shade structure shall remain in a park between sundown and sunrise.
- b) No person shall possess a propane tank on any public property except that persons with a city-approved permit may possess one UL-listed residential, propane-fueled gas grill or heater in a city park provided that the propane is a maximum twenty poun bottle connected to the grill or heater. No permitted tank shall be located closer than ten feet from the nearest combustible structure. No person shall leave any park without first having completely extinguished any fire. The prohibitions of this sub-section do not apply to the possession of multiple propane tanks for the purpose of transportation to or from private property or in connection with an approved city special event permit.
- (c) Prohibited items located on city property within a radius of five-hundred feet from any point on a school property line or within fifty feet on both sides of any multi-use path are subject to prioritized removal. Signage or other notification methods may be used to identify these boundaries.
- <u>Section 6</u>. The official ballot shall contain the following ballot title, which shall also be the designation and submission clause for the measure:

AN ORDINANCE SUBMITTING TO THE REGISTERED ELECTORS OF THE CITY OF BOULDER AT THE GENERAL MUNICIPAL COORDINATED ELECTION TO BE HELD ON TUESDAY, NOVEMBER 7, 2023, THE QUESTION OF, WITHOUT RAISING ADDITIONAL TAXES, EXTENDING THE EXISTING 0.15 CENTS CITY SALES AND USE TAX APPROVED BY THE VOTERS BY ORDINANCE 7300 BEYOND THE CURRENT EXPIRATION DATE OF DECEMBER 31, 2024, UNTIL DECEMBER 31, 2044, AND EARMARK THE REVENUE FROM THIS TAX EXTENSION TO FUND ARTS, CULTURE, AND HERITAGE; AS A VOTER APROVED REVENUE CHANGE; SPECIFYING THE FORM OF THE BALLOT AND OTHER ELECTION PROCEDURES; AND SETTING FORTH RELATED DETAILS

THE CITY COUNCIL OF THE CITY OF BOULDER, COLORADO, FINDS AND

RECITES THE FOLLOWING:

- A. The voters of the city approved a general-purpose sales and use tax in the amount of 0.15 cents on each dollar of sales, which tax expires at the end of 2024;
- B. Petitioners have submitted a petition to request that the voters consider authorizing City Council to continue a 0.15 cents on each dollar of sales and use tax from its present expiration date of December 31, 2024, and beginning January 1, 2025, and earmark the revenue generated solely for arts, culture, and heritage purposes; and
- C. It is appropriate for voters to approve of the continued collection, retention and expenditure of the full tax proceeds and any related earnings from this portion of the sales and use tax.

6	which seek to continue the 0.15 cent sales and use tax are on the ballot for this election. The
7	measures are in conflict regarding the authorized uses of the revenue generated by the tax.
8	Section 5. Pursuant to Sec. 53 of the Charter of the City of Boulder, if two or more
10	measures adopted or approved at the same election conflict in any of their provisions, they shall
11	go into effect in respect to such provisions that are not in conflict and the one receiving the
12	highest affirmative vote shall prevail insofar as the provisions conflict. If this measure is
13	approved and receives more votes than the other initiative which pertains to the extension of the
14	0.15 cent sales and use tax last approved pursuant to Ordinance 7300, then this measure will
15	become the law and such other initiative will not be implemented.
16	Section 6. If this measure is approved and receives the higher affirmative vote, the
17	Boulder Revised Code shall be amended to read as follows:

- A. The voters of the city have approved a sales and use tax in the amount 0.15 cents on each dollar sales, which tax expires at the end of 2024;
- B. The electorate should consider authorizing the City Council to continue a 0.15 cents on each dollar sales and use tax from its present expiration date of December 31, 2024, and beginning January 1, 2025, designate the revenue generated for fire and emergency response services, public safety services, homelessness solutions and services, arts, cultural, and heritage programs, parks, and other general fund purposes;
- C. It is appropriate for voters to approve of the continued collection, retention and expenditure of the full tax proceeds and any related earnings from this portion of the sales and
